President Jean Cheszek called the meeting to order. An agenda was previously distributed via e-mail.

NEW BUSINESS

- 1. **TREASURY**: D Shelton submitted the Treasury Report via E-mail (Exhibit A).
 - <u>Budget</u>: Given the current account balance and our desire to maintain a \$1500 reserve for 2020, the Board approved an increase in some event budgets and subsidies.
- 2. **SPONSORSHIP**: We have 16 sponsors who have paid for a total of \$9,000. We have two more sponsors for an additional \$2,700 who have committed but not yet paid.
 - ✓ The Robson Corporation has committed to sponsoring the Member/Guest tournament (\$2,500) but has not issued their check yet
 - ✓ Signs are ordered for the newest sponsors and should be ready for pickup in a week
 - ✓ Todd's Pest Control is a new Gold sponsor; as soon as their sign is ready we will assign them to an event targeting Home & Home if the sign is ready in time
 - ✓ Marci Whitehead is now coordinating the monthly Closest to the Pins.

3. **EVENTS**:

- **SBR Member-Guest**. Date: May 7. We have 55 people registered to date. The Board approved a budget increase of \$1500 (\$2500 to \$4000).
 - ✓ Terry Pettijohn has constructed 36 wood professional quality tee box markers for use in the Member-Guest and the Home, Home & Home at SBR. They require painting.
 - ✓ The putting contest awards will be golf balls.
 - ✓ Three of the newer model homes will be chosen for the scavenger hunt.
 - **ACTION**: A \$50 gift card will be obtained for Terry Pettijohn.
 - ACTION: A painting party will gather at 2 pm Friday April 19 at the Hawkins residence. T Kelly will research paint options from Home Depot.
 - ➤ **ACTION**: Available Board members will meet at 2 pm on Saturday April 20th at the Sales Office to select items for the scavenger hunt.
- Home, Home & Home: Date: April 23rd. "Rhinestone Cowgirls" is the theme. We have 13 people registered. Pairings will be random A,B,C,D with each team containing one host-course member. The format will be 2 best balls. The entrance fee is \$25 (annuals); \$60 (non-annuals). Some of the \$600 budget will go towards prizes. The closest to the pins will be reserved for non-SBR players. Door prizes will be considered if there are residual funds available.
