 - Completed regular monthly updates

- **5. MEMBERSHIP:** M.Whitehead reported that we currently have 98 Members. Discussion followed as to what we would do as an organization when we reach 100! Suggestion by C.Mihal a picture and article in The Ranch Roundup of our 100th Member. No decision was reached.
- **6. SPONSORSHIP:** P.Howitt reported that we have 1 new Sponsor at the \$200.00, and they plan to renew for next year, as well.
- 7. **COMMUNICATIONS:** C.Mihal had previously discussed with J.Cheszek and T. Fraser about creating an archive of SBRWGA "articles from the monthly Ranch Roundup" to be placed on our website. This was tabled for off-line review.
- **8. HANDICAP AND RULES:** T.Kelly reported that the Rules have been updated on our Website. A.Anna had no new updates on Handicap.

NEW BUSINESS

- **1. RESUMPTION OF LEAGUE DAYS:** J.Osterlund reviewed the Board's previous vote on resuming League Days, with games and monies. If our Membership decides against this, then all of our other tournaments would also be eliminated. It was decided that L.Smith, A.Anna and J.Osterlund would send out a survey to our entire Membership. Per M.Jahaske, the Pro Shop could charge with our Member Number, with winnings going to our accounts in the Pro Shop. If approved, we could resume League Play Days by June 9th.
 - ACTION: L.Smith has already sent out a "preliminary" survey for Board approval. When approved, this will be sent to our Membership.
- **2. MIXED STICKS:** C Mihal and M.Whitehead proposed that this tournament be reviewed later in the Summer. The SBRMGA is not organized to pursue, and it involves many "social" get togethers.
- **3. 3-PUTT JAR:** P.Horwitt reported that although this has been suspended, Judy Callahan has agreed to take over this responsibility when resumed. The \$'s in our current Jar have been put into our account, and is reflected on our April 14-May 2, 2020 Treasury Report.
- **4. LEAGUE DAY:** See item 2 above, under CHAIR REPORTS. Also discussed to put this into J.Osterlund's President's Message so that all of our Members understand how Golf Genius is Equitable to everyone.
