### **COMMITTEE REPORTS**

- **1. TREASURER:** D.Taylor had previously submitted the 11/9 12/13/21 Treasury Report There were no changes. The Projected carry-over to 2022 is approximately \$8500.00.
- **2. SPONSORSHIP**: P.Horwitt reported that there was a "revised" approach to Sponsorship, as a follow up from our previous meeting. As of this date, we have 3 new sponsors for 2022, for a total of \$1500.00.
  - **ACTION:** P.Horwitt to send out letter to board which was sent to sponsors which will provide clarification.
- **3. MEMBERSHIP:** M.Whitehead stated that there are 121 members total; however, 30 members had not yet renewed. Some have moved out of our area.
- **4. LEAGUE DAY:** S.Pharr reviewed the new Home, Home & Home event. Due to course closures, new dates are scheduled as follows:

- **6. RULES & HC**: T.Kelly reported that the local rules have been condensed for easier carrying. The webpage on the pace of play has been updated. A reasonable time for a round of golf here is 4 hours. A suggestion was made that new members should be teamed up with a person familiar with both our USGA and local rules for their first league round, and that they play from the combo blend of Plum/Gold.
- **7. COMMUNICATIONS:** C.Mihal reported that 4 articles have been turned in for the January issue of the Ranch Roundup.

## **NEW BUSINESS**

- **1. MV Invitation:** This event is scheduled for 2/15/22, with a reduced rate as approved by M.Jahaske, Director of Golf.
- **2. PLUM/GOLD COMBO TEES:** We had played these today during our League play. Determination as to where a member will play is up to each member. Comments were made by the Board on whether these were liked or not. S.Pharr made a motion to change our score cards accordingly, 2<sup>nd</sup> by D.Taylor. This was unanimously approved the Board.

It was determined that new members playing this combo will be an agenda item for January 2022. L.Smith suggested an ad hoc committee meeting of J.Jensen, T.Kelly, and T.Graves prior to that meeting in January, to review guidelines for playing/recommending these combo tees.

- **ACTION**: T.Kelly, T.Graves, J.Jensen and S.Pharr will meet and present their recommendation for tee choices at the January Board meeting.
- **3. MEMORIAL FOR R.GALANT**: Monies to be given to the charity that Nancy Galant had requested was suggested as \$100.00 by J.Osterlund, 2<sup>nd</sup> by M.Hawkins. Unanimously approved by the Board.
  - > **ACTION:** L.Smith to make a donation of \$100.00 in memory of Rich Galant.
- **4. GOLF MAINTENANCE & PRO SHOP HOLIDAY GIFTS:** J.Osterlund reported that \$10,000.00 has been collected for the Maintenance Crew and Pro Shop. M.Whitehead and T.Kelly are putting together "goodie" bags for each of the above, and will be distributed.
- **5. PURCHASE OF PICMONKEY SUBSCRIPTION**: S.Pharr discussed a subscription of PicMonkey and how it would help with our branding. The cost is \$6.00 per month, or \$72.00 per year. M.Hawkins recommended moving forward with this, 2<sup>nd</sup> by M.Whitehead. Board approved moving forward and purchasing PicMonkey unanimously.
