Current course maintenance and watering require players to take relief almost on every round: if a ball lands in standing water, vehicle ruts, or "ground under repair", free relief is granted, with ball cleaning as required to the nearest point of relief no closer to the pin. # **GOLF COURSE OPERATIONS - M. Jahaske**

Mike reported that the Greens Committee has been discussing the implementation of a year-round 8:00 am shot gun start. In the upcoming winter season, the Pro Shop is anticipating that golf rounds will be over 90% resident, a majority of which will consist of annual 18-hole rounds. The implementation of the shot gun on the busiest days, one of which is Tuesday SBRWGA league day, will enable more rounds for annual players while preserving 9-hole/twilight rounds which have a high demand. This has been communicated to all effected leagues and feedback is being solicited.

There was discussion about the proposed additional 9 holes for the SBR golf course and its impact on demand. Mike pointed out that the additional 9 holes would ease the demand for 9-hole and twilight rounds and allow for more available 18-hole tee times.

The golf course will be closed July 31 – August 6 for maintenance.

The meeting adjourned at 2:30pm.
