A motion was made to approve the previous month's minutes. The motion passed.

SUGGESTION BOX - J. Valverde

<u>Suggestion</u>: Have a "follow the field" group when SBRWGA has 2-day tournaments. Tuesday is the league play day and those that cannot play on Monday or 2 days in a row should not be denied playing.

This suggestion was discussed, and Cathy Steel and the League Day committee will work to implement a "follow the field" solution for 2024.

ACTION: Cathy to work to implement a "follow the field" solution for 2024.

<u>Suggestion:</u> Don't understand the reason for the Updegraff Cup to be played from PLUM tees only. The handicap system makes things equal from all tees.

This suggestion was discussed: first it was noted that the SBRWGA Policy and Procedures do not stipulate PLUM tee box and second the team captains were made aware of this concern.

<u>Suggestion:</u> Consider any rounds play in the Cat Cup towards the 10 prerequisite rounds for the Club Championship.

This suggestion was discussed, and it was pointed out that Cat Cup events are not SBRWGA events. The SBRWGA Policies and Procedures states: To be eligible to win either the Club Championship or Senior Club Championship, a member must have played and posted ten (10) SBRWGA League Day events within the prior 12 months of the tournament date.



<u>Suggestion:</u> The definition of "guest" for the purpose of inclusion in the SBRWGA Member Guest event was brought up at the 10/2/23 SBRWGA General Meeting. Put the definition of "guest" to SBRWGA membership via ballot vote.

This was discussed and three clarifications to this tournament format are:

- 1. The SBRWGA Policy and Procedures does not stipulate who is considered a guest. Members are those that are a member of SBRWGA.
- 2. One of the purposes of the Member/Guest event is to attract new members to SBRWGA.
- 3. The field would be limited because not all members have a guest that is "outside of SBR."

The definition of "guest" will not be put to the SBRWGA membership via a ballot vote.
