#### 5. Other Business:

- The Tennis and Pickleball Associations want to trade assisting with major events so that members can participate instead of working. The vote was a unanimous yes.
- Ringers: Changing the program requires a vote by the membership. The decision
  was made to continue for the remainder of this year but to change/eliminate it for
  next year. Proposal is to replace Ringers with awards for most improved (net only)
  quarterly by flight.
- In anticipation of creating the Nominating Committee for 2020 Board positions in September, Jeanne Osterlund proposed the following changes to job descriptions:
  - Vice President: Oversee major tournaments by coordinating with Play Day and Events. Schedule meetings, collect money, create list of attendees, balance funds and monitor budget. Major tournaments include Club

- Champion, President's Cup, Member Guest, Member Member, Sadie Hawkins and Solheim.
- Communications: Reinstate as a board position. Write and submit Round Up articles, send out mass emails, recruit and assign photo responsibilities.
- o Handicap will be aligned with Rules again.
- Reiterate that even though there may be multiple people sharing a board position, there is only one vote per position. I.e.: Play Date, Sponsorship, and Rules/Handicap each has only one vote.
- Plan was proposed by Debbie Shelton, seconded by Alex Anna and voted unanimously if favor of adopting.
- ACTION: Jeanne Osterlund will make necessary changes to the By Laws and Policy and Procedures to incorporate these changes as well as the Ringers. She will work with Trish Kelly to achieve this prior to our next meeting.

## 6. Next Board Meeting:

 The Board will meet on September 3 to approve the proposed By Laws so they can be presented to the general membership one week prior to the General Meeting for voting.
